## WATER CONNECTION APPLICATION

### 1.0 SCOPE

- 1.1 The terms and conditions as set out in the current Rates and Rules for Water Service by Parr Utilities Ltd. as approved by the Comptroller, Water Utility Act, shall apply to all customers supplied with service by the Water Utility.
- 1.2 The Tariff, as approved by the Comptroller, Water Utility Act, is available for public inspection at the offices of the Water Utility.

### 2.0 APPLICATION FOR SERVICE

- 2.1 The customer may apply for connection or reconnection of service at the Water Utility's offices by the completion and execution of this Water Connection Application, and by the payment of such charges as may be required pursuant to the current Tariff.

### 3.0 CUSTOMER WATER SERVICE CONNECTION REQUIREMENT

#### 3.1 **Service Pipes**

The customer shall be responsible at its cost to install water service piping on its property, and from the Water Utility's curb stop to the premises. Service pipes are to be 20 or 25mm Blue 904 Pex Corporation Stop-Curb Stop and stand pipe. No service pipe or fittings shall be covered until they have been inspected and approved by the Water Utility. 48 hours notice must be given to the Utility to ensure prompt inspection of the connection.

#### 3.2 **Shut-off Valve/Stop Cock**

At the point of entry of the water service connection inside the customer's building, the customer is required to provide and install at its cost a shut-off valve (stop cock) to be located at a point prior to the pressure reducing/regulating valve and water meter.

#### 3.3 **Pressure Reducing/Regulating Valve**

The customer is required at its cost to install a pressure reducing/regulating valve on the water service inside the building, just after the shut-off valve and just before the water meter assembly to protect their property from any unforeseen changes in pressure in the water line.

#### 3.4 **Water Meter**

The customer is required to provide and install at its cost a new Neptune 5/8X3/4" T-10 meter with an E-Coder R900i (m3) register, available from:

The water meter is to be installed just after the Pressure Reducing Valve. The water meter must be installed horizontally, and if necessary be installed with a meter horn to meet that requirement. All water supplied by the Water Utility to the customer must pass through the meter prior to its use by the customer.

Upon installation of the water meter system by the customer, the plumbing and installation of the meter will be inspected and if approved, sealed by the Water Utility. 48 hours notice must be given to the Utility to ensure prompt inspection of the connection. Upon sealing of the water meter system by the Water Utility, the meter becomes the property of the Water Utility and shall not be bypassed by the customer. The customer shall permit the Water Utility access into the customer's premises from time-to-time to inspect, repair or replace the water meter assembly as may be required by the Water Utility.

The customer will be responsible for any damage to the water meter due to freezing or improper care.

3.5 **Check Valve/Backflow Preventors**

The customer is required to provide and install at its cost a check valve/backflow preventors just past the water meter assembly in order to protect the water system from contamination.

4.0 **CURB STOP**

4.1 No person who is not an authorized agent or employee of the Water Utility shall turn on or off the curb stop to start or stop water supply to a customer.
